### **Aviation Rescue**

**Project Detail:** The Australian government and the Australian Maritime Safety Authority (AMSA) contract operators to protect Australia's borders and also conduct search and rescue missions to save lives. These operations cover a vast geographical surface of 52.8 million kilometres and missions are conducted by aircrew and rescue officers in both rotary and fixed wing aircrafts in both civil and defence contexts.

Currently the existing qualifications AVI30519 - Certificate III in Aviation (Rescue Crew Officer) and AVI40119 - Certificate IV in Aviation (Air Crew Officer) are skewed towards rotary aircraft. Existing packaging rules and the content of the Units of Competency make it impossible to attain competency in either fixed wing or a non-defence context in which the missions can be conducted.

The project review will seek to enhance the qualifications usability across multiple sectors including State Emergency Services and other specialist emergency services using fixed wing aircraft. The review will also identify redundant Units of Competency. The review provides the opportunity for air crew and rescue crew officers who work on fixed wing aircraft to attain a nationally recognised qualification and boost career progression and workforce mobility in closely associated sectors.

### **Training Product Priority**

### Routine

The project is in response to industry needs to enhance the recognition of VET qualifications and ensure they meet industry needs and practices. The project is routine and requires a period of 12 months to be completed.

## **Transport Security Protection**

**Project Detail:** The Department of Home Affairs acts as the security regulator for the aviation, maritime, and air cargo sectors, setting the training and qualification requirements for security screening officers for these sectors. This project is in response to recent regulatory changes requiring screening officers to hold the AVI20118 Certificate II in Transport Security Protection for the aviation and maritime sectors. This requirement came into effect on 16 January 2022 for the aviation and maritime sectors and 1 January 2023 for the air cargo sector.

The project will review the qualification to ensure it meets regulatory requirements and has the necessary specifications to produce for competent and regulatory compliant cargo screeners.

### **Training Product Priority**

#### Routine

Airport security screening is a vital part of airports' operations and is regulated by the Department of Home Affairs. Due to recent regulatory changes and reported challenges in delivering the content of this qualification, the Department have requested the need to review and update this qualification to ensure it reflect the latest security screening technologies and industry practices. The project requires a period of 12 months to be completed.

## **Diploma of Aviation (Flight Instructor)**

**Project Detail:** The Diploma of Aviation (Flight Instructor) is the most used qualification to train flight instructors. There are currently 16 TAE Units of Competency including eight core Units of Competency that have been superseded and one core Unit that has been deleted. The changes are making it difficult for aviation schools and training organisations to deliver this qualification as it comes closer to the allowed ASQA transition period for superseded content. The Diploma of Aviation is a costly course which makes it imperative to revise the qualification to ensure students' certificate includes the updated Units of Competency and they are not having to go out and undertake further training to be current trainers.

### **Training Product Priority**

### Complex

Flight Instructors' role includes highly technical and non-technical tasks underpinned by a sound knowledge of educational theories and practices. The imported core and elective Units of Competency from the TAE Training Package require updating to the latest requirements to ensure there is no significant gap for flight instructors.

Stakeholders have also indicated their interest in aligning the qualification more closely with Civil Aviation Safety Authority's (CASA) Flight Instructor Rating Grade 3 licencing, standards and resources. Closer alignment with CASA licencing requirements significantly enhances the qualification's industry recognition and utility. The alignment will require consultation with a broad range of industry stakeholders and CASA to manage their requirements.

The project requires a period of 12 - 18 months to be completed.

## Remote Pilot Licence (RePL) Alignment

**Project Detail:** Drone utilisation in Australia is rapidly increasing across a wide range of industries. Drones enhance efficiency and accuracy in many tasks. This growth underscores the significance of training and compliance with regulations to ensure skilled and compliant drone operators. There is currently a misalignment between the Certificate III in Aviation (Remote Pilot) and Civil Aviation Safety Authority's (CASA) Remote Pilot Licence which presents a challenge for students. Despite completing the Certificate III, students are not awarded the CASA RePL, necessitating additional time and financial investment to complete CASA's course independently. This redundancy undermines the value of the Certificate III qualification. Aligning the Certificate III with CASA's RePL requirements enhances the qualification's industry recognition.

### **Training Product Priority**

### Routine

The project requires a period of 12 months to be completed. Consistency between the VET system and CASA regulations is crucial for creating a more efficient and effective pathway for aspiring remote pilots.

### Marine Order 505

**Project Detail:** After a 3-year period of industry consultation, a new maritime regulation known as Marine Order 505 (MO505) (Certificates of competency – National Law) for domestic commercial vessels came into effect on 1 January 2023.

Seafarers must hold an approved Australian Maritime Safety Authority (AMSA) Certificate of competency to perform the duties required by job roles on a vessel in Near Coastal waters, which includes the achievement of a maritime training package qualification or Skill Set and Units of Competency. In response to MO505, AMSA has requested that maritime training products for Near Coastal job roles be reviewed to reflect MO505 licensing and regulatory information.

These job roles include:

- General Purpose Hand
- Coxswain Grade 1, Coxswain Grade 2
- Master <100 metres, Master <45 meters, Master <24 meters</li>
- Master Inland Waters
- Engineer Class 3
- Marine Engine Driver (Grade 1), Marine Engine Driver (Grade 2), Marine Engine Driver (Grade 3).

### Routine

AMSA has confirmed this project is in response to a licensing and regulatory need and that the nominated Near Coastal broad range of job roles will require substantial public consultation and extended stakeholder engagement, which requires a period of 12 months.
