The reason for reaching out to Skills Insight is regarding the unit that we will retain in the Maritime Training Package. The unit MARC044 Transmit and receive information by marine VHF radio appears in some of your qualifications as the below table notes.</p> <p>We wanted to make you aware of the situation even though it doesn’t impact in the normal way on your training package in case some of your stakeholders got concerned.</p> <p>Basically, we will retain MARC044 Transmit and receive information by marine VHF radio in the Maritime Training Package and will not be amending it as part of the deletion of the qualification and other units. There will be a webinar as part of our consultation for deleting to let stakeholders know more detail.</p>	ISA developed a DEWR submission for this project.
